Lincoln Mullen

Lincoln Mullen is a historian of American religion and the nineteenth-century United States, often using computational methods for texts and maps. He is the executive director of the Roy Rosenzweig Center for History and New Media, a research center which creates websites, podcasts, educational resources, data-driven histories, and other open-access digital work to democratize history. At George Mason University, he is a professor in the Department of History and Art History, where he teaches American religious history, the history of Christianity, the history of the nineteenth-century United States, and digital history.

Sarah Imhoff

Sarah Imhoff is Assistant Professor in the Department of Religious Studies and the Borns Jewish Studies Program at Indiana University, Bloomington. Her research explores how bodies and their attributes, such as gender, race, and ability, shape and are shaped by religion. Her current research project is a hemispheric history of Judaism in the Americas, bringing together the stories of Latin America and the Caribbean with those of North America. She is the founding co-editor of the journal American Religion.

Main Question

"We should be thinking about how race and antisemitism interact: how and when is antisemitism like other forms of racism? How and when is it something else, such as religious prejudice? And how does Jewish whiteness interact with this? How can Jews be both white and objects of racial antisemitism?"
